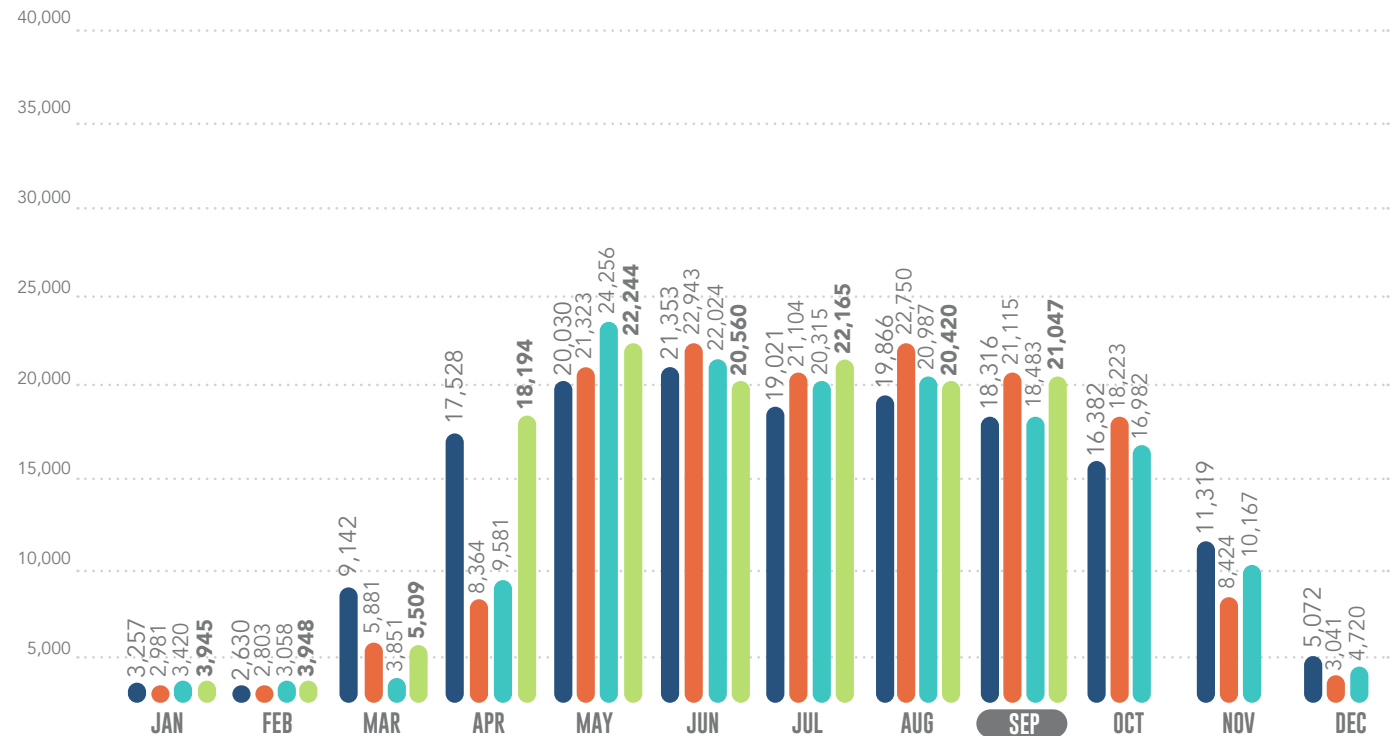

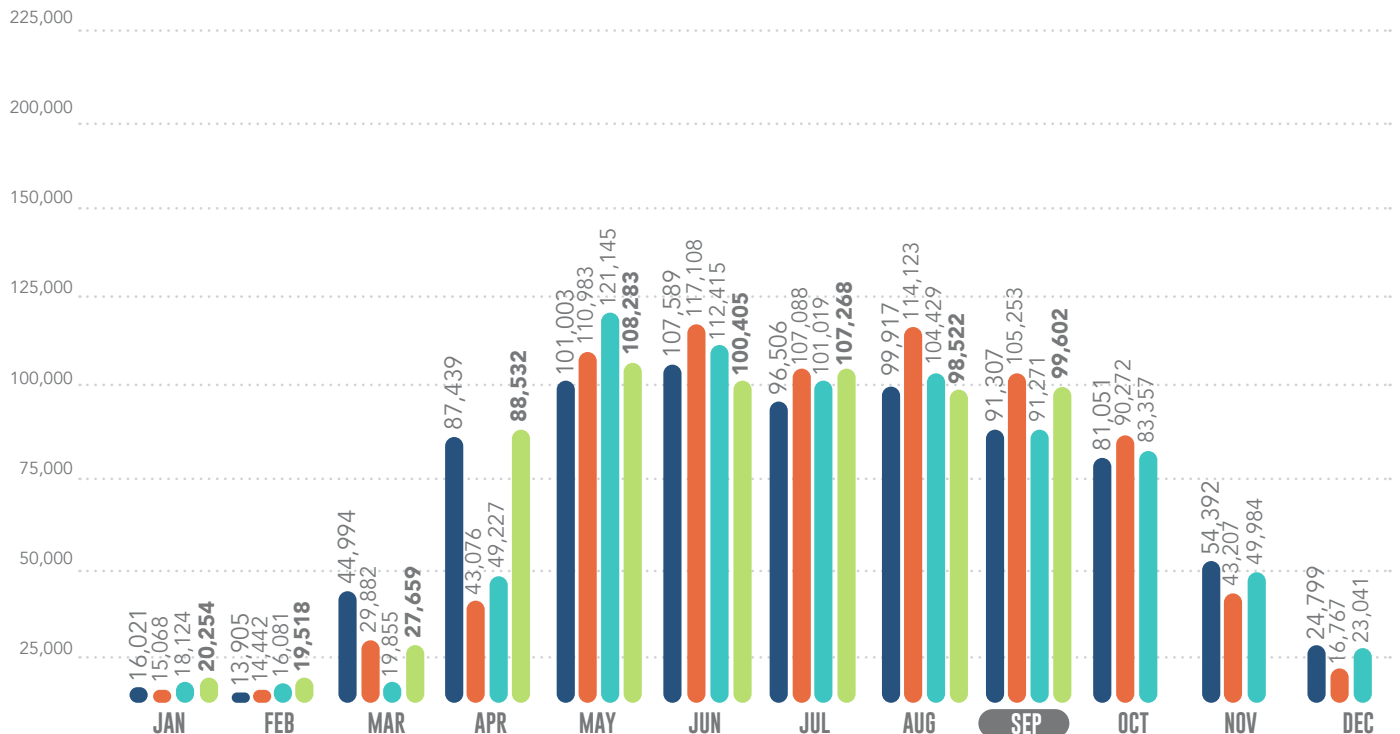

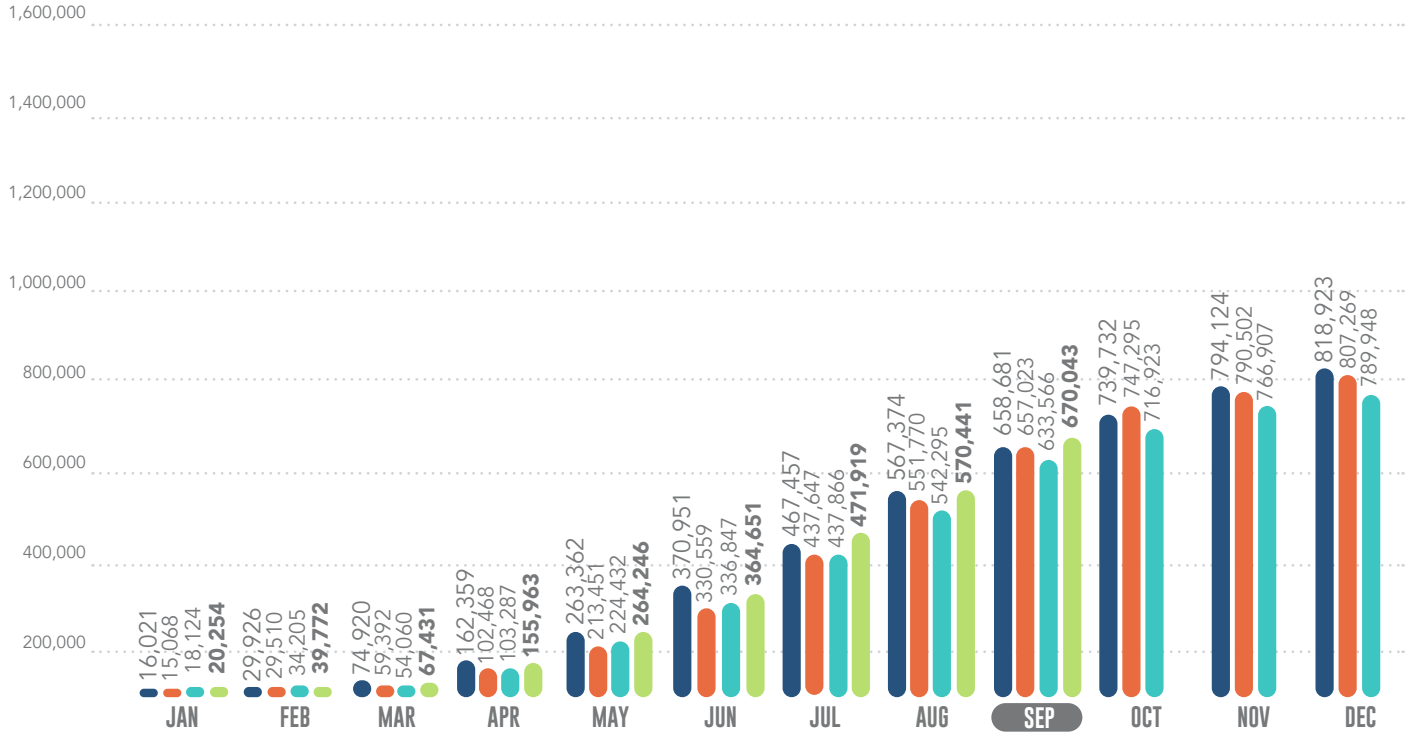

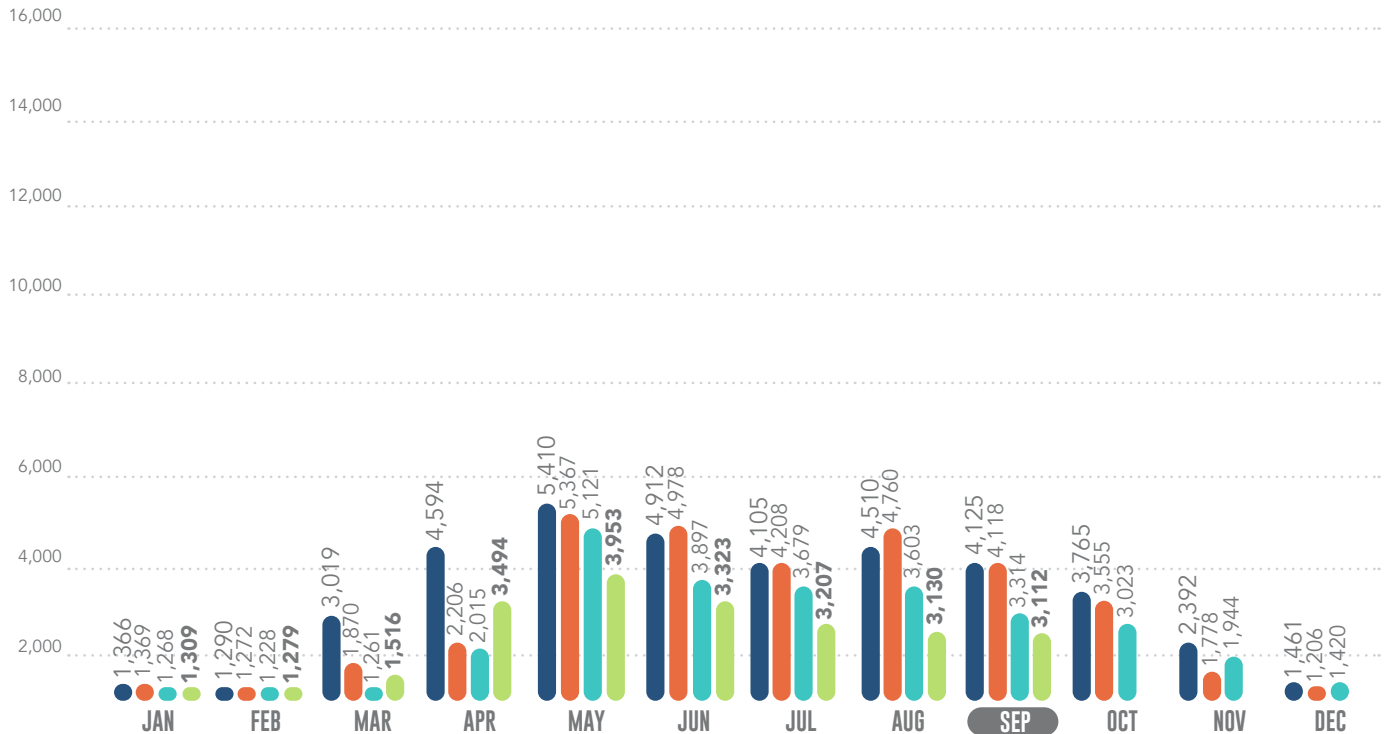
OUTGOING TICKETS Y-T-D

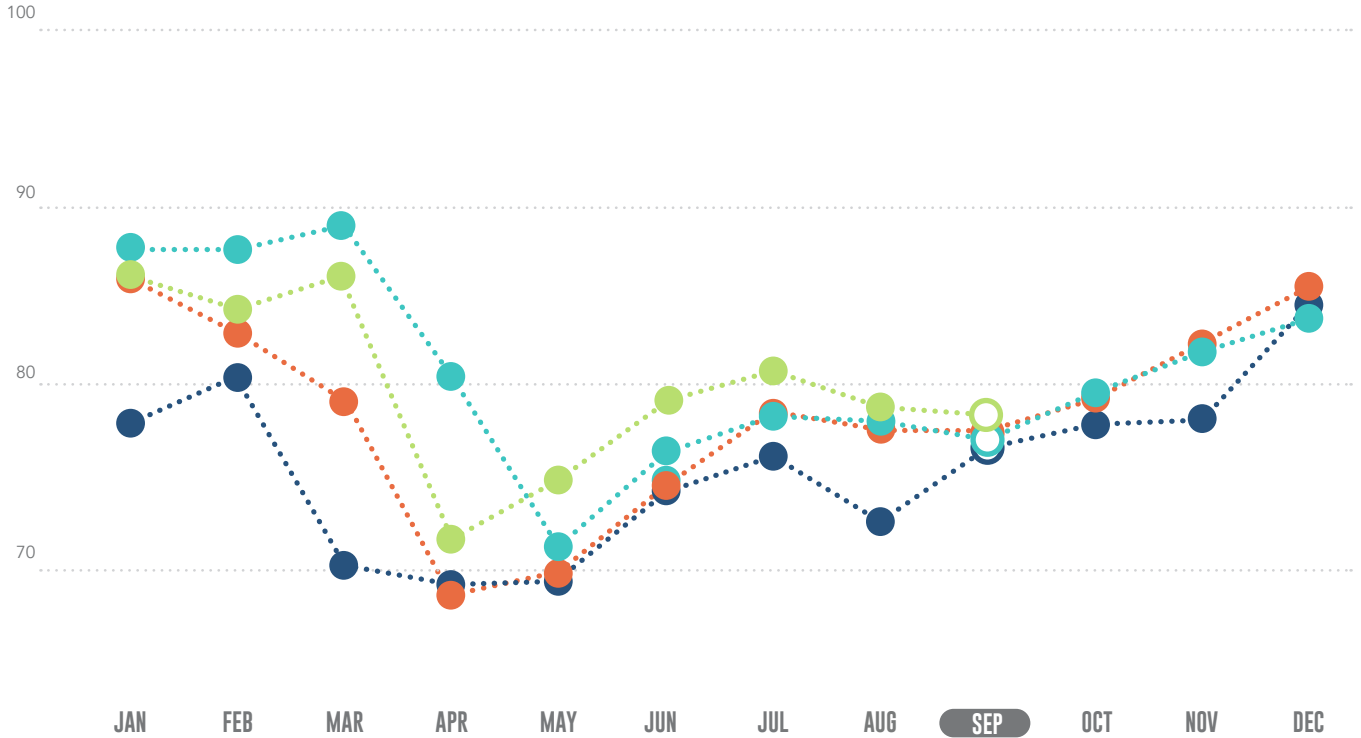

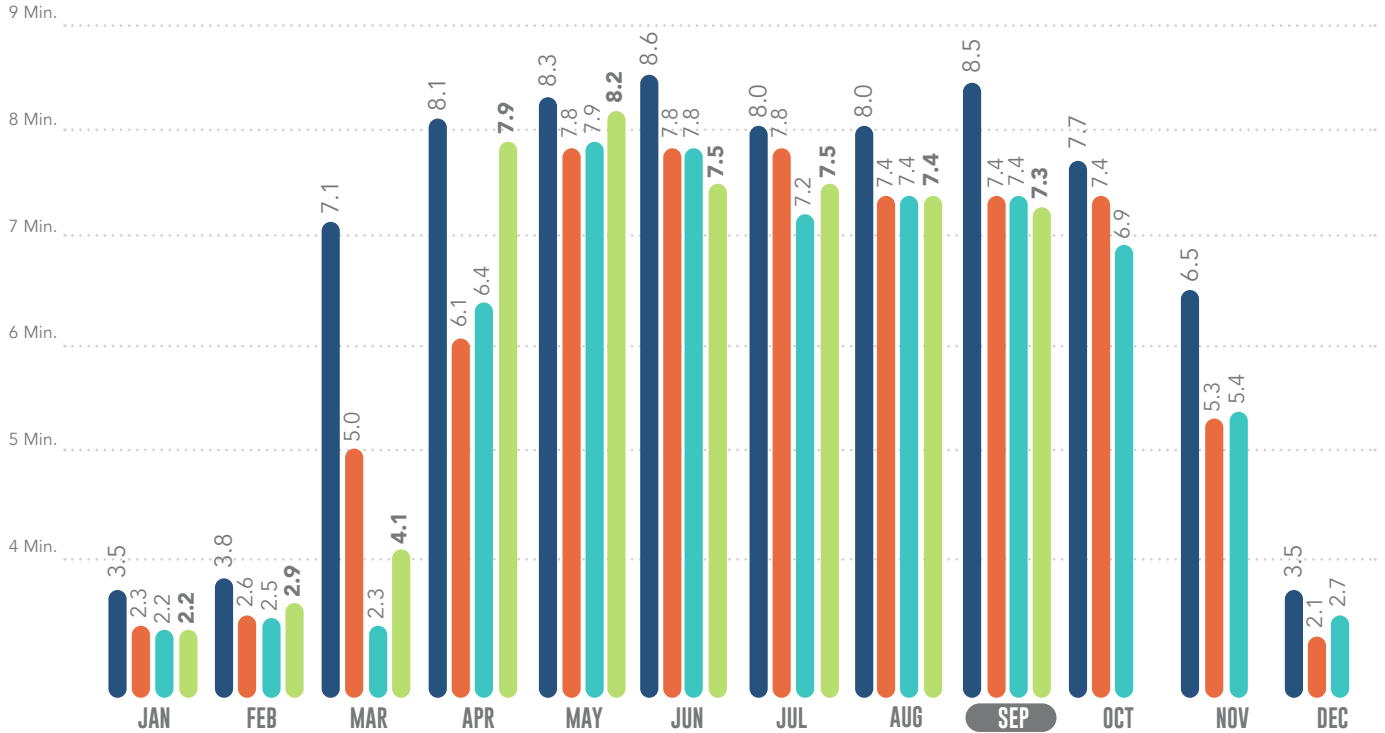

2021 2022 2023 2024



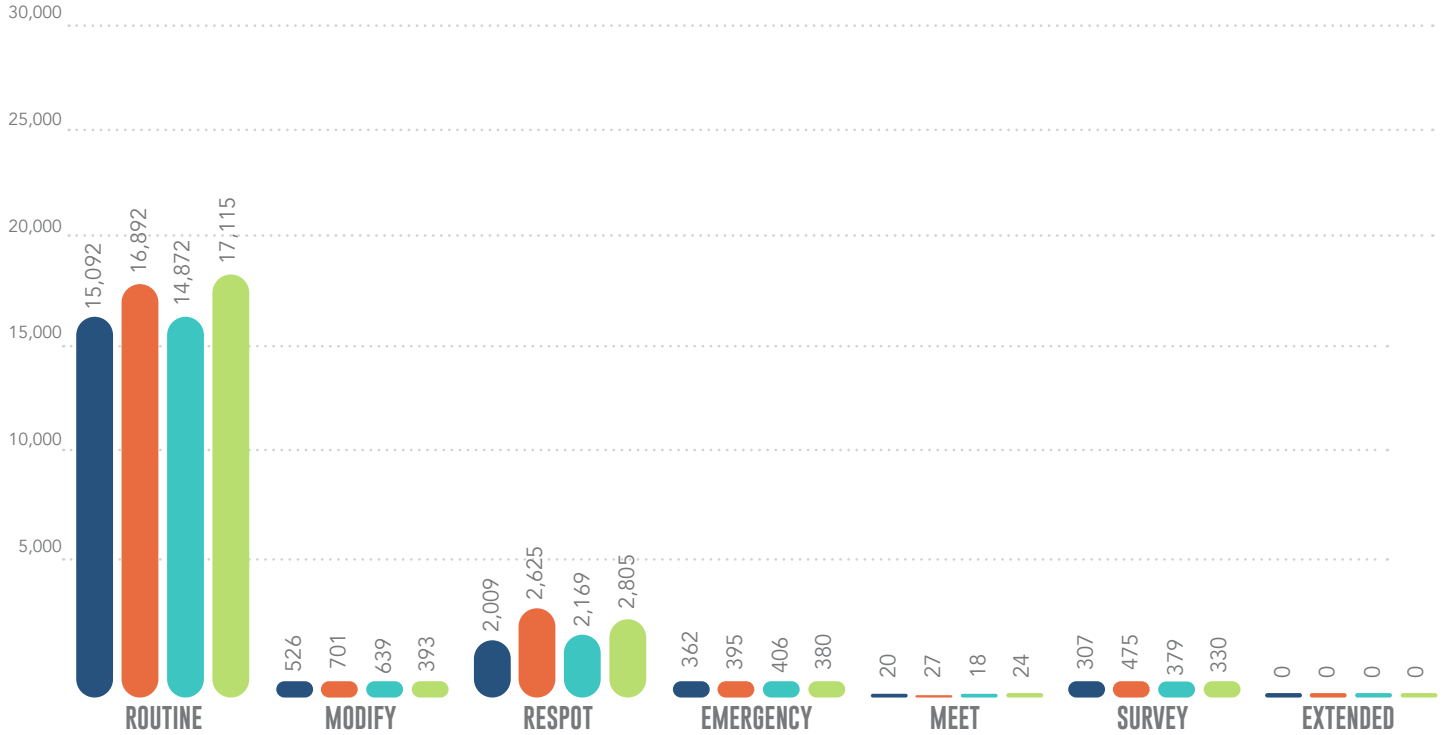

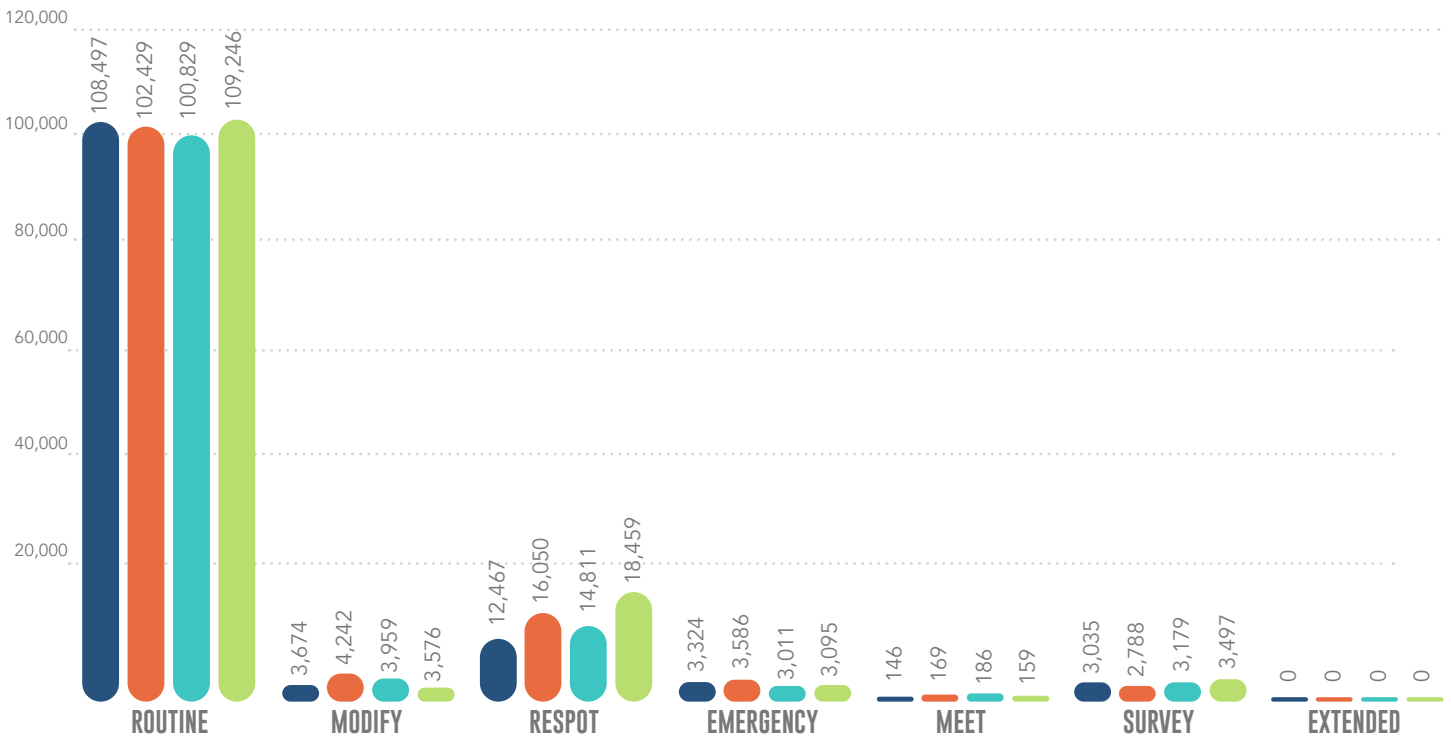
INCOMING TICKET TYPES SEP

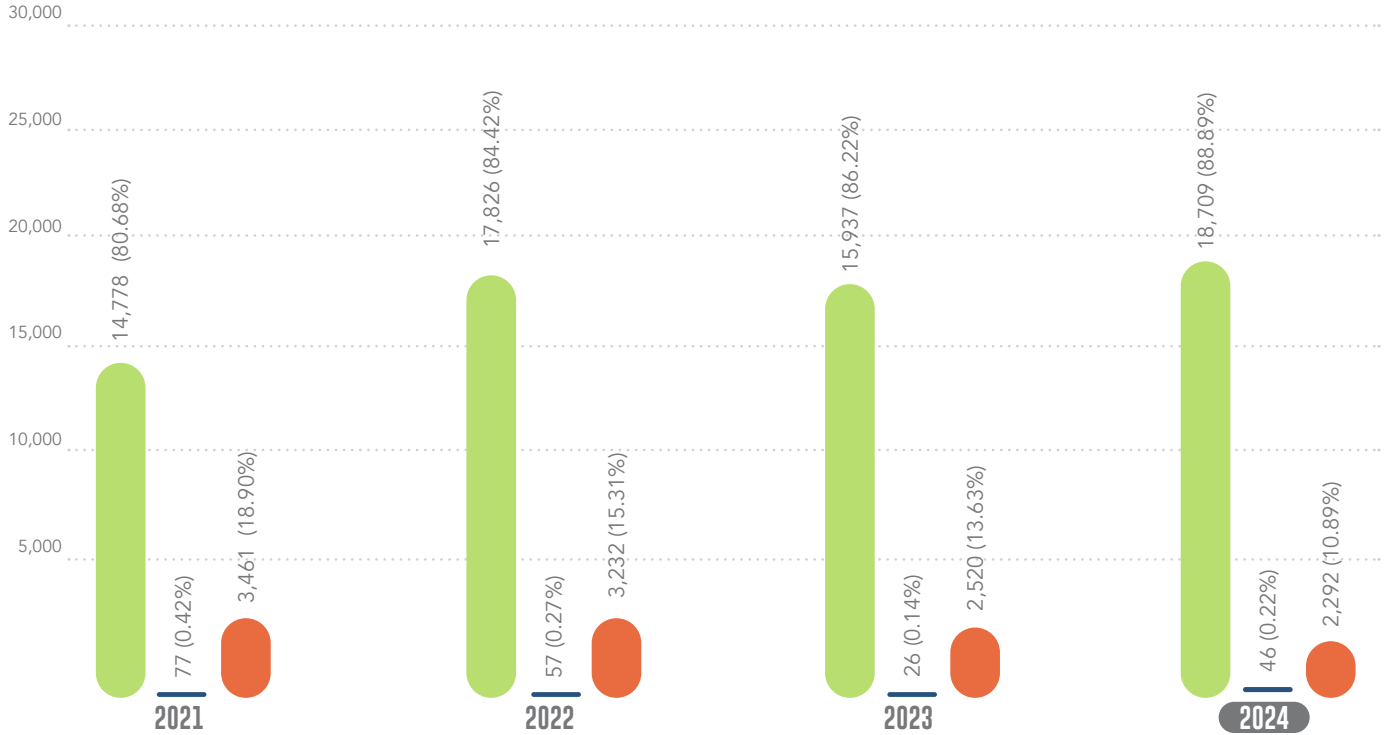

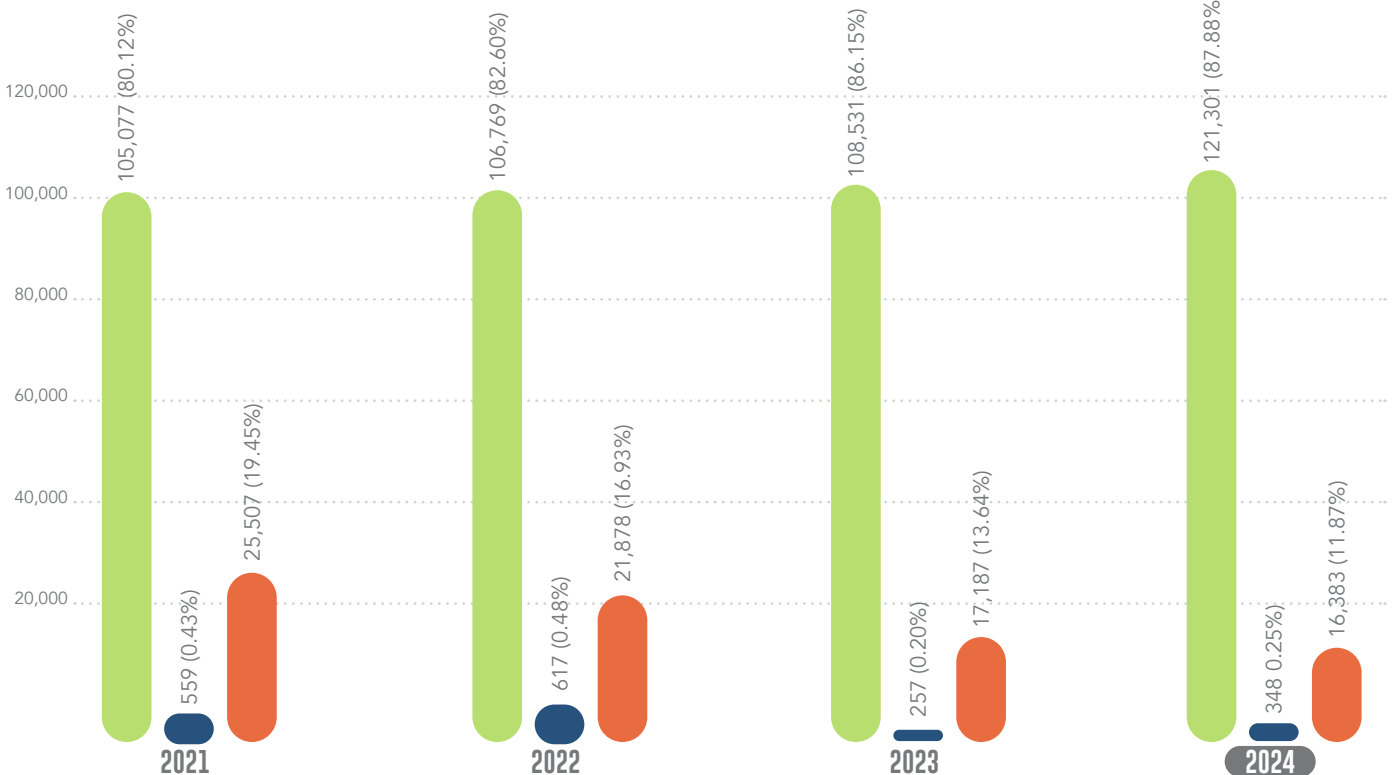

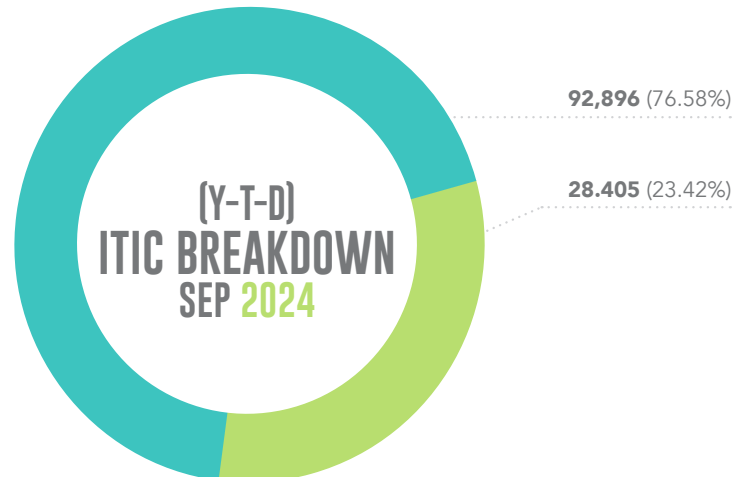
OVERALL ITIC % - 86.23%

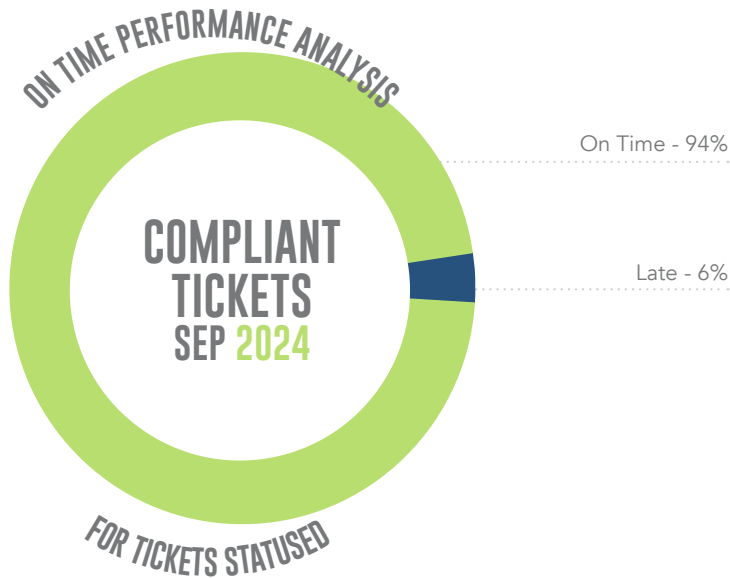
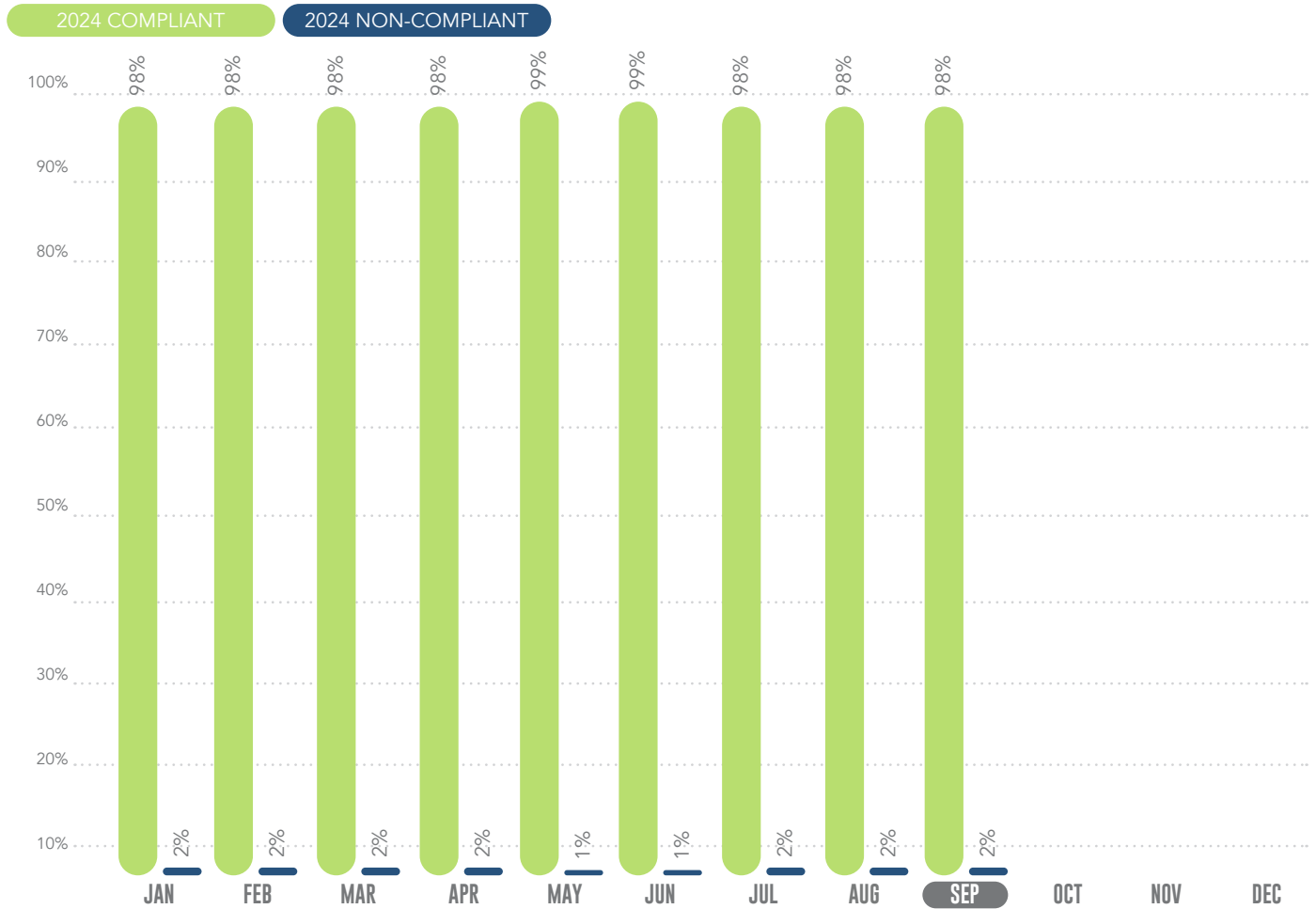

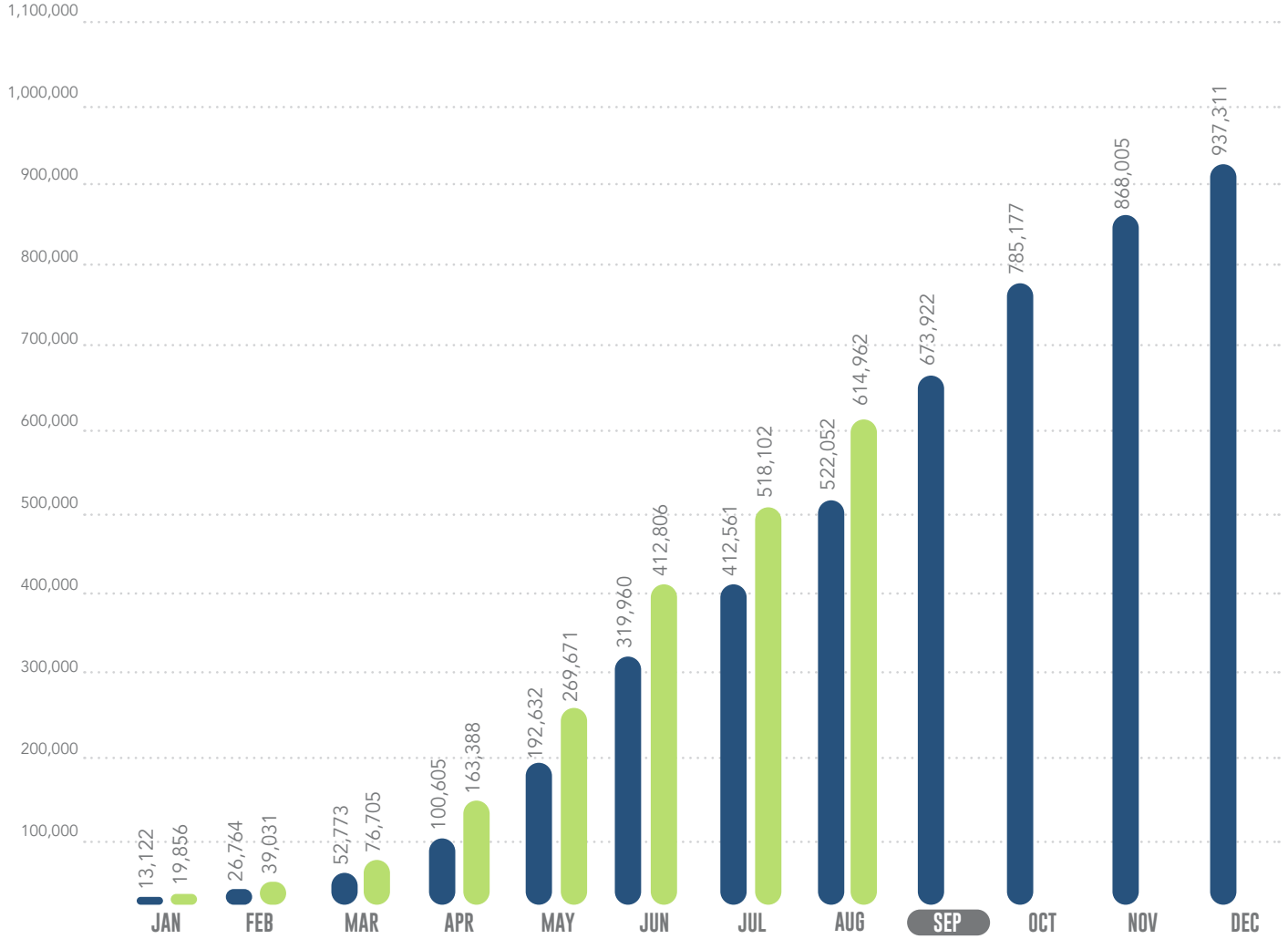
